The **Medical Intervention Risk (MIR) Report** is a new report derived from the well-known Battery for Health Improvement 2 (BHITM 2). The MIR Report was designed for healthcare providers to evaluate pain and injury patients for surgical, opioid and rehabilitation intervention risk. The MIR Report helps to assess risk related to whether the patient will:

- Adhere to treatment
- Abuse opioids
- Return to work
- Be satisfied with surgical outcomes

The report assesses five psychosocial risk factors to consider prior to medical intervention and summarizes them in a brief, easy to read format: primary, presurgical, rehabilitation, addiction history, and addiction potential. The report also provides scores for **catastrophizing** and **kinesiophobia**—two nonadaptive coping styles that interfere with achieving optimal outcomes.
